GV Victoria Refund Policy for Tuition and Fees

This policy has been approved by the Private Training Institutions Branch (PTIB) of the British Columbia Ministry of Post-Secondary Education and Future Skills and is compliant with the Private Training Act. See the dispute resolution policy for further details.

- **Definitions:** In this policy, the word “course” refers to the full cycle of studies to which the student registered. The “course start date” refers to the start date listed in the student contract. In case of transfer from one school to another, the earlier contract date is the course start date.
- **Refund Procedure:** A student may be entitled to a refund of tuition fees in the event that the student provides notice to the school that he or she is withdrawing from the course; or the student provides a copy of the visa rejection letter from IRCC, or the school provides notice to the student advising that the student has been dismissed from the program. The notice of withdrawal or dismissal may be delivered in any manner, provided that a receipt or other verification is available that indicates the date on which the notice is delivered. The notice of withdrawal or dismissal is deemed to be effective from the date it is delivered.
